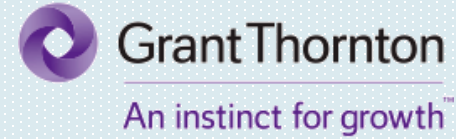
## 2023, October - ?

*Goal - to expand the range of issues compared to the traditional topics of the gas business. How to accelerate the green transition for Ukraine under current conditions. These are general issues of the security of Europe's energy infrastructure, the stability of energy systems, the issue of optimal construction of distributed generation systems, including generation based on gas turbines operating both on natural gas and on water, construction of wind power plants and others.*

### *Suggested topics for discussion:*

- The world is changing. Place of Ukraine on the world energy map
- Market risks in energy markets. Competition and cooperation
- Physical and cyber risks for energy infrastructure. Lessons learnt from Ukraine
- Regulatory risks for the supply of energy resources
- New energy. The great shift to green gas : new reality or fantasies of the future?
- EU and Ukraine. Renewable energy. Areas of cooperation
- Restoration of energy infrastructure as a result of military operations

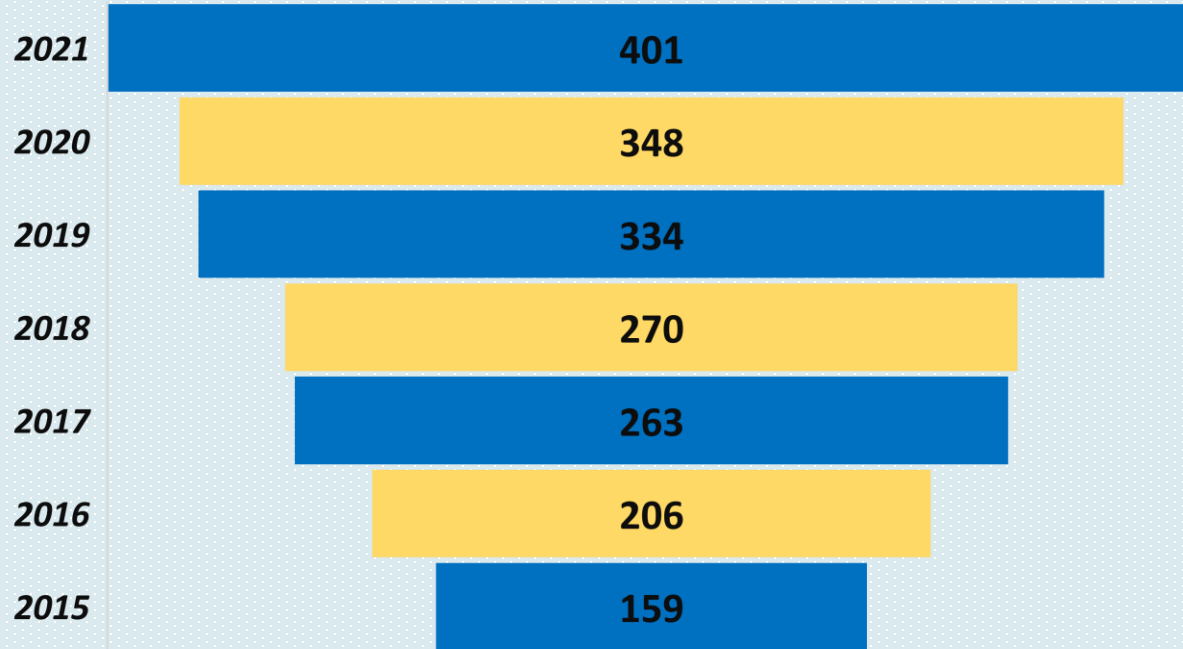
### 2015 - Ukraine's gas market: Europe's last frontier?

*Goal - to provide an objective view on the gas market of Ukraine, the real opportunities, as well as the difficulties that arise when doing business in such a large and undeveloped market*

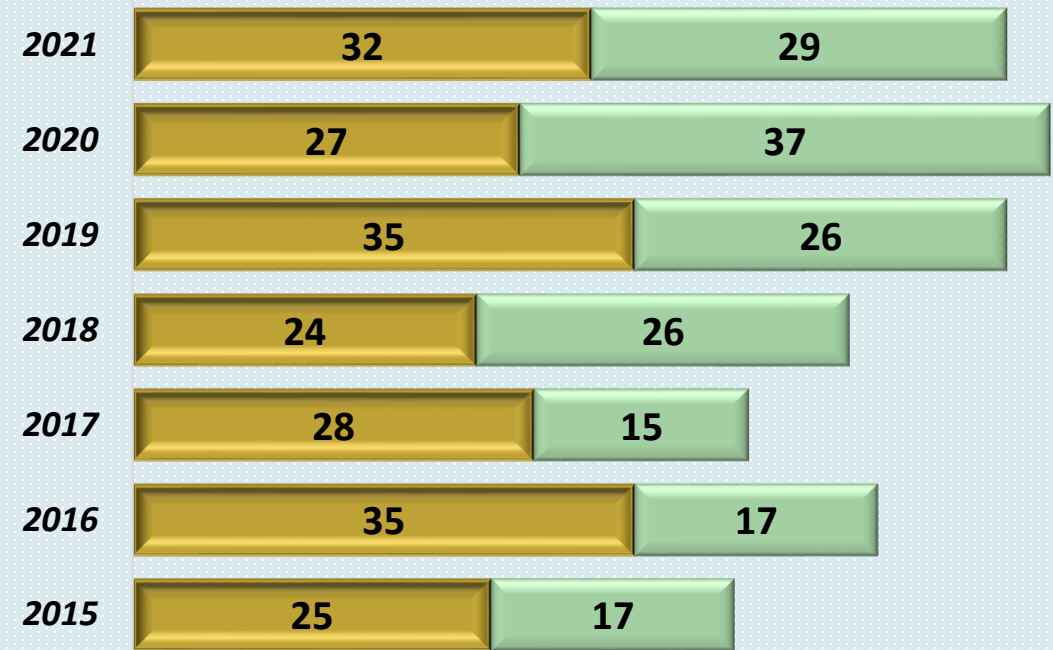


## Statistics of the Ukrainian Gas Forum (by years)
